WARRANTY ON THE COX® TABLE

1 Year - Limited Warranty
FOREIGN

- All Cox ® Tables manufactured and sold by TRACK CORPORATION are warranted to be free from defects in material and workmanship (except upholstery) for a period of twelve months from the date of shipment.
- Outside the continental United States, the labor portion of the warranty is void.
- This warranty is only for the benefit of the original purchaser and applies only to the Cox® Tables purchased at the full table price.
- If any part should fail to conform to this agreement or to any warranty outlined herein, Purchaser's remedies shall be limited to the repair or replacement, at the company's option, of the non-conforming part by our service department or a trained technician from our service department. Any repairs made from outside service organizations without prior authorization from TRACK CORPORATION will null and void all warranty agreements. Purchaser shall report any defective part or other problem to the company or dealer for service scheduling.
- Jumping, hammering, or beating on the instrument may cause serious damage to mechanism. Any such damage will be covered outside the warranty agreement.
- The purchaser shall be solely responsible for the use and application of the product notwithstanding whether such use or application has been consented to or approved by the company.
- Defective conditions caused by *misuse, abuse, Acts of God, accidents, abnormal use or stress, defective electrical installation, uncontrolled electrical current, modifications, alterations or any other matter unrelated to TRACK CORPORATION and beyond its reasonable control are not covered.*
- TRACK will not warrant any electrical changes due to electrical conversion made once the table arrives in Europe.
- TRACK places responsibility for the table's proper delivery and set up in foregin customers' offices with the purchaser. TRACK will certainly be available if you need any information about the table (email, phone, fax). All other warranty issues are limited to replacement of components which is consistent with the current warranty policy (see above) if an end user is outside of the continental United States.
- THE WARRANTIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL WARRANTIES, WHETHER ORAL OR WRITTEN, EXPRESSED OR IMPLIED, INCLUDING WHERE ALLOWED BY LAW, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL TRACK CORPORATION BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM ANY BREACH OF WARRANTY, INCLUDING BUT NOT LIMITING TO LOSS OF REVENUE, LOST PROFITS, LOSS OF USE, DOWNTIME, DAMAGE TO OR REPLACEMENT OF EQUIPMENT OR PROPERTY.
